Consequent upon the additional allocation conveyed by the Administrative Department vide letter No. FCS&CA/PlanPMGKAY-V/Alloc/2020-21 dated - 02-12-2022 (copy enclosed) to the extent of 7531.23 Qtls of foodgrains viz; 6637.34 Qtls of Rice and 893.89 Qtls of Wheat under PMGKAY (AAV+PHH) in lieu of the savings deducted earlier for the month of November 2022, you are hereby directed to lift the foodgrains from FCI by 15-11-2022 as per the table given below:



Sir,

I am directed to invite your attention to the proposal received vide your
aforementioned communication, and to convey additional allocation of **753.123 MTs of
foodgrains (89.389 MTs of wheat + 663.734 MTs of Rice)** under PMGKAY (AAY+PHH
category) in lieu of savings deducted earlier for the said month while making allocation.

It is reiterated that all the distribution should be through POS devices only and no
manual distribution should be made as directed earlier. Any such distribution shall not be
accepted henceforth and responsibilities shall lie with the Directorate and concerned ADs. In
the event of any justified reasons the matter should be reported promptly to Administrative
department for obtaining prior approval.

The lifting of the foodgrains should be ensured within the validity period 15.12.2022.
