**CLARIFICATION**

In view of the representation preferred by the President - Bakery Association Kashmir and President Sweets and Namkeens Association Kashmir and in order to clear the doubts and ambiguity among masses regarding rates fixed / revised for "Katlam" and "Finni", the following changes shall take effect forthwith:-

*"That the items like "Katlam" and "Finni" shall be recognized and categorised as Bakery, Sweet & Namkeen items and shall not be a part of rate list issued for B-Class Tea Stalls, so as to ensure that quality and standard of these items is not compromised with."*

*"The rates for "Katlam" and "Finni" will remain the same as already fixed by this Department vide Notification issued under endorsement No. DFCS&CAK/S/Rate-Bakery/2020/4487-97, dated. 23-09-2020."*
