

Consequent upon the allotment of foodgrains (Fortified Rice) conveyed by the Administrative Department vide above referred communication under the Scheme for Adolescent Girls (SAG) Saksham Anganwadi and Poshan 2.0 for 3rd quarter 2023-24, you are hereby directed to procure/ lift Rice (Fortified) from FCI within the validity period to the extent of 105.20 MTs for its further release in favour of Assistant Directors of FCS&CA Baramulla and Kupwara as per the district wise breakup given hereunder;

The Assistant Directors of FCS&CA Baramulla and Kupwara shall ensure lifting of complete allocated quantity for its further dispatch to the respective sale outlets and subsequent lifting by the concerned Anganwadi centres.
