Whereas, the Administrative Department, FCS&CA Civil Secretariat J&K Jammu vide letter No. FCS&CA/Estt/69/2019 dated 15.10.2021 forwarded select list of candidates (received from Department of Disaster Management, Relief, Rehabilitation and Reconstruction, Civil Secretariat, Jammu vide No. DMRRR-MR/154/2021 dated 14.10.2021 / J&K Service Selection Board vide No. SSB/Secy/Sel/2021/7046-53 dated 14.10.2021) for three hundred (300) posts of Depot Assistants carrying substantive pay level of Rs. 14800-47100 (SL-1), in Food, Civil Supplies & Consumer Affairs Department, District Cadre Kashmir;


Whereas, this office vide notification issued under endorsement No. DFCS&CAK/Adm/B-X-25/EC3 dated 15.10.2021 informed all the concerned candidates to submit their verification rolls in triplicate in the offices of Directorate of Food, Civil Supplies & Consumer Affairs Kashmir / Jammu for verification of their character and antecedents which also got published in local dailies of Jammu and Kashmir viz The Daily Aftab Srinagar on 16.10.2021, Kashmir Images on 16.10.2021 and Daily Excelsior Jammu on 16.10.2021;

Whereas, after receipt of provisional /final security clearance from Criminal Investigation Department J&K in respect of 205 candidates, appointment orders in respect of 193 candidates stands already issued;


Whereas, the appointment orders in respect of 12 candidates could not be issued due to withholding of recommendations by J&K Service Selection Board, which are yet to be released;

Whereas, seventeen (17) appointed candidates as detailed in the annexure "A" to this notification failed to join within the stipulated time period of twenty-one (21) days and, as such, their appointment is deemed to have been cancelled ab-initio as per General Administration Department's Circular No. 08 JK(GAD) of 2019 dated 04.12.2019;

Whereas, thirty-five (35) candidates as detailed in the annexure "B" to this office notification have failed to submit their verification rolls in triplicate in the offices of Directorate of Food, Civil Supplies & Consumer Affairs Kashmir / Jammu till date in response to this office notification dated 15.10.2021 duly published in local dailies of Jammu and Kashmir, which reveals that they are not interested to join this department



Now, therefore, in view of above, the candidates as detailed in the annexure "C" to this office notification are advised to submit their verification rolls in triplicate in the offices of Directorate of Food, Civil Supplies & Consumer Affairs Kashmir / Jammu for verification of their character and antecedents within a period of fifteen (15) days from the date of publication of this notice in leading newspapers of Jammu and Kashmir, so that waiting list against the fifty-two (52) posts which includes seventeen (17) non-joining candidates and thirty-five (35) candidates who failed to submit their verification rolls is operated accordingly.
