As reported by the Chief Accounts Officer and other Drawing & Disbursing Officers (District Assistant Directors) of Food, Civil Supplies & Consumer Affairs Department, Kashmir vide their aforementioned references, the employees mentioned in Annexure-A to this order are retiring from services on attaining the age of superannuation with effect from the dates as depicted against each during the calendar year 2024.


The concerned Assistant Directors will submit proposal well in advance where suitable arrangements are required to be made. The Assistant Directors/ Sectional Heads will attach suitable officials with the retiring officials under their administrative control so that no difficulty is faced in discharging of Government work at the time retiring officials are relieved. This should be given due attention, enabling the official so attached to become conversant with the work by and by.

The Chief Accounts Officer / Assistant Directors will ensure the details of all the employees working under their administrative control attaining the age of superannuation during the calendar year 2024, if not already included in the list and forward same to the Administration Section (Direction Office) so that no official is left out or retained beyond the date of retirement for which they will be personally responsible as the establishment / service records are being maintained by them. They will also verify the outstanding /FIR, if any, pending against these

retiring officials and submit reports to Direction Office for necessary action. The cases where recovery is being made in instalments such type of cases should be reviewed and amount of recovery be re-fixed and recovered accordingly well before retirement of such official as required under rules.

The concerned DDO's shall submit their pension papers duly completed in all respects to Direction Office for taking further necessary action.

Now, therefore, the date of retirement of these employees on attaining age of superannuation as shown against each in Annexure-A to this ^{notification} is hereby notified for information of all the concerned.
