Whereas, the Department of Disaster Management, Relief, Rehabilitation and Reconstruction, Civil Secretariat J&K Jammu vide Government order No. 34 JK (DMRRR) of 2022 dated 22.06.2022 has asked for maintenance of separate seniority for the employees appointed under Hon'ble Prime Minister's Package by the appointing departments which shall run parallel to the seniority of the regular employees and shall take effect from the date of appointment;
