

Consequent upon the decisions taken in the meeting regarding review of Mutton rates held under the chairmanship of the Divisional Commissioner, Kashmir on 27-02-2021 and 17-03-2021 and in supersession of all previous notifications issued on the subject and in exercise of powers conferred under Rule - 13 of Jammu & Kashmir (Mutton Licensing Control) Order, 1973 read with SRO - 31 dated 31-01-1974, L. Bashir Ahmad Khan, Director - Food, Civil Supplies & Consumer Affairs Department, Kashmir hereby revise and re-fix the rates of Mutton as under: -

<u>Classification</u>	<u>Wholesale rate/Kg.</u>	<u>Retail rate/Kg.</u>
1. Dressed Mutton without offal	Rs.495/- per Kg.	Rs.535/- per Kg.
2. Dressed Mutton with offal (100 gms.)	---	Rs.490/- per Kg.
