

Accordingly, the Assistant Director Stores/ Mills FCS&CA Kashmir is hereby authorized to lift Foodgrains to the extent of 2989.25 Qtls viz; 1816.30 Qtls of Rice under PHH category and 1172.95 Qtls of Wheat under AAY category from FCI on urgent basis for its further release in favour of districts as already conveyed vide Order No. 788-DFCS&CAK of 2023 dated:- 08-09-2023 for the month of **October 2023**.

The other terms and conditions shall remain same as have been conveyed by the Administrative Department as well as by this Directorate vide aforesaid orders.

Sir,

Kindly refer to the subject and reference cited above. In this context undersigned is directed to convey that pending reconciliation of advance allocation made under NFSA for ONORC and pending receipt of reimbursement of ONORC from GOI, the additional allocation of **298.925 MTs** of foodgrains (**181.63 MTs of Rice under PHH category and 117.295 MTs of wheat under AAY category**) is made under NFSA in your favour, for its distribution during the month of October 2023 amongst the genuine beneficiaries across Kashmir division with the condition that all the distribution of foodgrains should be through PoS devices only, strictly as per the entitlements and no manual distribution is allowed as directed earlier.

The lifting of foodgrain should be ensured urgently.
