Consequent upon the directions conveyed by the Administrative Department for fulfilling the main border plan before the onset of winter season, **Sanction is hereby accorded in favour of Assistant Director Stores/ Mills for:**

1. Lifting/ procurement of Foodgrains to the extent of 22130.16 Qtls of Rice and 452.14 Qtlf of Wheat from FCI under NFSA/ NPHH by or before 05th of October 2023 in advance as per the category wise breakup given hereunder :

Release of Foodgrains to the extent of 22130.16 Qtls of Rice and 452.14 Qtls of Wheat under NFSA/ NPHH in favour of Assistant Director FCS&CA Bandipora and Kupwara for main border areas in advance by or before 05th of October 2023 as per the district wise/ category wise breakup given in Annexure "A" to this order.
3. Release of Foodgrains to the extent of 10309.94 Qtls of Rice and 1435.55 Qtls of Wheat under NFSA/ NPHH out of available savings at divisional level in favour of Assistant Director FCS&CA Bandipora and Kupwara for main border areas in advance by or before 05th of October 2023 as per the district wise/ category wise breakup given in Annexure "A" to this order.
4. Lifting/ procurement of Rice to the extent of 8430.40 Qtls of Rice from FCI by or before 05th of October 2023 under PMFSS at OMSS (D) rates for its further release in favour of Assistant Director FCS&CA Bandipora and Kupwara for main border areas in advance as per the district wise breakup given in Annexure "B" to this order.

The allocation has been released in advance in favour of district Bandipora and Kupwara for main border areas under NFSA/ NPHH and PMFSS for the period of November 2023 to June 2024 for dumping at sale destinations and subsequent distribution as per the notified scale/ rate conveyed by the Administrative Department on monthly basis through PoS devices only.

The Assistant Director FCS&CA Bandipora and Kupwara shall ensure to lift entire released quantity of Foodgrains in advance and dispatch to the respective sale destinations within the stipulated time frame for distribution in respective months through PoS devices only in favour of bonafide beneficiaries as per approved scale/ rate conveyed by the Administrative Department unless changed earlier.

However, the terms and conditions shall remain same as envisaged in the allotment orders conveyed from time to time.
