Sub:- Grant of retrospective effect to the promotion of Mr. Shamas ud Din Haroon, Assistant Storekeeper R.No. 4689

Whereas, Mr. Shamas ud Din Haroon, ASK R.No. 4689 represented before this office stating therein that he had been engaged in this department as Daily wager, regularized on 01.04.1994 as Class-IV, being due for promotion as Assistant Storekeeper during the year 2007 on the analogy of officials appointed as DWs after him and having been promoted prior to him;

Whereas, Mr. Shamas ud Din Haroon requested that he may be taken at par with his junior counterparts to safeguard his seniority and pensionary benefits;

Whereas, the case of Mr. Shamas ud Din Haroon was placed before the Departmental Promotion Committee Meeting held on 03.02.2021;

Whereas, the DPC examined the case of Mr. Shamas ud Din Haroon and it was observed that he has been regularized as Class-IV w.e.f. 01.04.1994. The official was due for promotion against the upgraded post of Assistant Storekeeper during the DPC held on 07/08.10.2007, however he was not cleared as Rs. 56,300/- were reported outstanding against him;

Whereas, in the next DPC held on 24.01.2009, he was cleared for promotion as Assistant Storekeeper vide order No. 93 DCA&PDK of 2009 dated 05/02.2009 w.e.f. 24.01.2009;

Whereas, the official viz Mr. Mohammad Ayoub Dar, R.No. 4695 (i.e. junior to Mr. Shamas ud Din Haroon in the DPC held on 08.10.2007) has been promoted as Storekeeper in the pay scale of Rs. 5200-20200 + GP 2400 (pre-revised) Revised 25500-81100 (L 4) by the Departmental Promotion Committee Meeting held on 23.10.2019 w.e.f. 01.10.2019;


Whereas, Departmental Promotion Committee in its meeting held on 03.02.2021 after examination of the case of Mr. Shamas ud Din Haroon took the following decision;

"Cleared notionally from due date i.e. as Assistant Storekeeper w.e.f. 08.10.2007 & Storekeeper w.e.f. 01.10.2019 subject to Vigilance Clearance"

Whereas, Mr. Shamas ud Din Haroon retired from services on attaining the age of superannuation w.e.f. 30.04.2021;

Whereas, necessary vigilance clearance in respect of Mr. Shamas ud Din has been received from GAD (Vigilance) Civil Secretariat through online mode vide Form No. 41120 dated 10.01.2022 reported nothing adverse against him;

Now, therefore, in view of above, the promotion granted to Mr. Shamas ud Din Haroon vide order No. 93 DCA&PDK of 2009 dated 05.02.2009 as Assistant Storekeeper in the pay scale of Rs. 5200-20200 + GP 1900 (pre-revised) w.e.f. 24.01.2009 shall take effect from 08.10.2007 and as Storekeeper in the pay level of Rs. 25500-81100 (L 4) w.e.f. 01.10.2019 notionally and monetarily w.e.f. 01.04.2021.
