Sub- Re-fixation of seniority of Mr.Ahsanull Haq Khan Tehsil Supply Officer R.No.4037 in the tentative seniority list of Tehsil Supply Officers/Inspectors carrying pay level of Rs. 35400-112400 (L-6)

Whereas, Mr. Ahsanull Haq Khan, TSO represented before this office wherein he stated that he has been promoted as Tehsil Supply Officer w.e.f. 01.10.2019, has been brought at par with his counterparts and requested that his seniority in the seniority list of TSOs at appropriate place may kindly be fixed;

Whereas, the case of Mr. Ahsanull Haq Khan was placed before the Departmental Promotion Committee meeting held on 03.02.2021. The Departmental Promotion Committee in its meeting held on 03.02.2021 after examination of the case of Mr. Ahsanull Haq Khan took the following decision;

*“Cleared notionally from due dates i.e. as ASK w.e.f. 28.05.2002, SK w.e.f. 17.08.2015 subject to verification of genuineness of Matriculation certificate and Vigilance Clearance”*

Whereas, pursuant to the DPC decision dated 03.02.2021, genuineness of matriculation certificate of Mr. Ahsanull Haq Khan conveyed by State Board of School Education Srinagar vide No. F(JS-Ver-X)B/KD/2021/F-4217 dated 27.04.2021 followed by receipt of satisfactory vigilance clearance from GAD (Vigilance) Civil Secretariat J&K through online mode vide Form No. 42328 dated 04.01.2022, this office vide order No. 265 DFCS&CAK of 2022 dated 04.02.2022 accorded sanction to the grant of retrospective effect to the promotion of Mr. Ahsanull Haq Khan as Assistant Storekeeper w.e.f. 28.05.2002 and as Storekeeper carrying pay level of Rs. 25500-81100 (L 4) w.e.f. 17.08.2015 notionally and monetarily with immediate effect i.e. w.e.f. 04.02.2022;

Whereas, Mr. Ahsanull Haq Khan again represented before this office stating therein that his junior counterparts are already working/confirmed as Tehsil Supply Officers and requested for similar treatment in his favour;

Whereas, the request / plea of the official was examined and it was found that one Mr. Manzoor Ahmad Bhat, R.No.4038 (immediate/first junior to Mr. Ahsanull Haq) has been confirmed as Tehsil Supply Officer w.e.f. 01.10.2019 vide order No. 289 DFCS&CAK of 2020 dated 25.02.2020 pursuant to the decision of Departmental Promotion Committee Meeting dated 23.10.2019;

Whereas, subject to confirmation by DPC, this office vide order No. 305 DFCS&CAK of 2022 dated 10.03.2022 accorded sanction to the placement of Mr. Ahsanull Haq R.No. 4037, Storekeeper carrying substantive pay level of Rs. 25500-81100 (L 4) as I/c Tehsil Supply Officer in his own pay and grade with charge allowance as admissible under rules with immediate effect and it was envisaged in the said order that to protect seniority of Mr. Ahsanull Haq, his promotion as Tehsil Supply Officer shall take effect notionally w.e.f. 01.10.2019 i.e. from the date, his junior counterpart namely Mr. Manzoor Ahmad Bhat, TSO R.No. 4038 has been accorded.

Whereas, the case of Mr. Ahsanull Haq was placed before the Departmental Promotion Committee meeting held on 09.04.2022 and following decision was taken;

"Cleared notionally from the date his junior counterpart has been cleared as TSO i.e. as TSO w.e.f. 01.10.2019 and monetarily w.e.f. 10.03.2022 (date of his placement as I/c TSO)"

Whereas, pursuant to the DPC decision dated 09.04.2022, this office vide order No. 398 DFCS&CAK of 2022 dated 24.05.2022 accorded sanction to the promotion of Mr. Ahsanull Haq Khan as Tehsil Supply Officer in the pay level of Rs. 35400-112400/- (L-6) w.e.f. 01.10.2019 notionally and monetarily w.e.f. 10.03.2022;

Whereas, the tentative seniority list of TSO/Inspectors has been issued vide Notification referred to above for inviting objections;


Whereas, the official who was immediate junior to Mr. Ahsanull Haq i.e. Mr. Manzoor Ahmad Bhat, R.No.4038 is appearing at S.No. 71 i.e. below Mr. Abdul Lateef Dar R.No.4034 (S.No. 70) in the tentative seniority list of TSO/Inspectors issued vide Notification dated 05.02.2022;

Whereas, before fixing seniority of Mr. Ahsanull Haq TSO is re-fixed at 70/A i.e. below Mr. Abdul Lateef Dar R.No.4034 and above Mr. Manzoor Ahmad Bhat, R.No.4038 in the tentative seniority list of TSO/Inspectors issued vide Notification referred to above, a notification issued under endorsement No. DFCS&CAK/Adm/B-X-304 dated 16.07.2022 was accordingly issued for inviting of objections, if any, from the concerned employees / officials of this department within a period of (15) fifteen days from the date of issuance of this notification;

Whereas, the notification No. DFCS&CAK/Adm/B-X-304 dated 16.07.2022 was given wide publicity both through print and electronic media (departmental website);

Whereas, no objection was received within the stipulated time period, besides, till date; Now, therefore, in view of above, it is hereby ordered that the seniority of Mr. Ahsanull Haq TSO R.No. 4037 is re-fixed at S.No. 70/A in the tentative seniority list of TSO/ Inspectors issued vide Notification No. DFCS&CAK/Adm/B-X-304 dated 05.02.2022 i.e. below Mr. Abdul Lateef Dar R.No.4034 and above Mr. Manzoor Ahmad Bhat, R.No.4038 and is accordingly notified for the information of concerned employees/officials of the department.

This is, however issued subject to outcome of writ petitions, if any, pending before any Hon'ble Court of law.
