In order to fulfill the annual border plan of Foodgrains in respect of Kupwara Borders and Gurez (Bandipora), Assistant Director Stores/ Mills FCS&CA Kashmir are hereby directed to release 25308.86 Qtls of Foodgrains viz: 24718.35 Qtls of Rice and 590.51 Qtls of Wheat under NFSA in favour of Assistant Directors of FCS&CA Kupwara and Bandipora for main border areas as per the category wise breakup given in Annexure "A" to this order out of the available savings reported vide their letters referred above.

The Assistant Directors of Kupwara and Bandipora shall ensure lifting of the entire released quantity (which includes advance quantity as well) and ensure its dispatch/ dumping at the respective sale outlets/ storage units as per FIFO methodology for its further distribution amongst bonafide rationees through PoS devices only as per share entitlement on monthly basis strictly as per the instructions of Administrative Department.

The above allocation is however, subject to the fulfillment of other terms and conditions conveyed from time to time.
