Whereas, Mr.Ghulam Hassan Bhat, Storekeeper, R.No.4346 alongwith other counterparts was cleared for promotion as Tehsil Supply Officer by the Departmental Promotion Committee meeting held on 23.10.2019;

Whereas, the orders for promotion in his favour as Tehsil Supply Officer could not issued due to non-receipt of vigilance clearance in his favour;


Whereas, Mr. Ghulam Hassan Bhat represented before this office stating therein he was due for promotion as Tehsil Supply Officer in the DPC held on 23.10.2019, however, he was not considered due to non-receipt of vigilance clearance which was later on received, but formal promotion order in his favour is yet to be issued;

Whereas, as per the records, his counterparts/Jr. Counterparts have been cleared for promotion as Tehsil Supply Officer w.e.f. 01.10.2019 as per DPC decision dated 23.10.2019;

Whereas, Mr. Ghulam Hassan Bhat has put in five years of regular service as Storekeeper as on 30.09.2022 which is pre-requisite for next promotion as Tehsil Supply Officer as per recruitment rules;

Whereas, the promotion order in favour of above official could not be issued due to non-receipt of vigilance clearance which was later on received as satisfactory;

Now, therefore in view of above, and as recommended by DPC dated 23.10.2019 with due protection of his seniority, sanction is hereby accorded to the release of grade of Tehsil Supply Officer in the pay level of Rs. 35400-112400 (L-6) w.e.f. 01.10.2019 notionally i.e. the date his junior counterpart have been cleared by DPC dated 23.10.2019 and monetarily with effect from 01.10.2022.
