In view of the request made by the Assistant Director Stores vide letter No. DFCS&CA/ADS/5360-5362 dated:- 15-10-2022, this office in continuation to Order No. 541-DFCS&CAK of 2022 dated:- 13-10-2022 is hereby conveying authorization for:

1. Lifting /Procurement of 6804.11 Qtls of Rice under NPHH from FCI as advance for winter dumping areas by Assistant Director Stores FCS&CA Kashmir.
2. Release of 6804.11 Qtls of Rice under NPHH in favour of Assistant Directors of FCS&CA Baramulla and Budgam to the extent of 3203.80 Qtls and 3600.31 Qtls respectively as advance for Snow Bound Dumping areas by Assistant Director Stores FCS&CA Kashmir.

The concerned Assistant Directors shall lift the entire released quantity and ensure its dispatch/ dumping to the respective sale outlets/ dumping centers for distribution amongst bonafide rationees through PoS devices only from December 2022 as per the instructions of the Administrative Department.

Besides, the released quantity in respect of districts shall be recouped on monthly basis by or before March 2023 under respective categories.

The above allocation is however, subject to the fulfillment of terms and conditions already conveyed vide order dated: 13-10-2022.
