- Lifting/ procurement of Foodgrains to the extent of 148.32 Qtls of Rice and 129.07 Qtls of Wheat from FCI by Assistant Director FCS&CA Stores under Inter State/ National Portability (NFSA) by or before 27th of November 2022.
- Release of Foodgrains to the extent of 148.32 QHs of Rice and 129.07 QHs of Wheat
  in favour of Assistant Directors of FCS&CA Kashmir division by Assistant Director
  Stores/Mills FCS&CA Kashmir under Inter State/ National Portability as per the
  district wise breakup given in Annexure "A" to this order.

The Assistant Directors of FCS&CA Kashmir Division shall ensure lifting/dispatch of allocated foodgrains at an earliest under Inter State/ National Portability (ONORC) and all efforts should be made to increase ONORC transactions.

Further, it is brought to notice of all concerned Assistant Directors that the above quantity is based on reimbursement allocation made by the GOI for first two quarters (April 2022 to September 2022) for ONORC against the quantity distributed throughout the division and thus the allocation made earlier/remaining balance out of the same and the quantity now released shall be utilized in promoting transactions under ONORC in a hassle free manner during current month (viz; November, 2022) and during succeeding months.

Besides, the concerned DPMU units at District Head Quarters be directed to capture and compile the details of transactions on National Portability.
