
In continuation to Order No. 575-DFCS&CAK of 2022 dated:- 15-11-2022 and in pursuance to the allotment of Foodgrains (Rice) conveyed by Administrative Department vide above referred communication, the Assistant Director Stores FCS&CA Kashmir is hereby authorized for:-

1. Lifting /Procurement of 3472.25 Qtls of Rice from FCI by or before 30th November 2022 under NPHH category for the month of December-2022.
2. Release of 3472.25 Qtls of Rice under NPHH category in favour of Assistant Director - FCS&CA Baramulla for the month of December - 2022.

The Assistant Director Baramulla shall ensure lifting/ dispatch of entire released quantity to the respective sale outlets within the stipulated time for its further distribution amongst genuine beneficiaries for the month of December - 2022 through PoS devices only as per the scale/ entitlement notified by the Administrative Department under respective category.

Pertinently, the Assistant Director Baramulla shall adhere with the conditions of the Administrative Department i.e. the distribution should be ensured through PoS devices, strictly as per the entitlement and the distribution process should be authenticated by concerned Mohalla Committees for greater transparency.

The above allocation is however, subject to the fulfillment of terms and conditions already conveyed vide order referred hereinabove dated:- 15-11-2022.
