The physical verification of stocks in all Godowns and Sale Outlets as on 31-03-2023 in Kashmir valley shall be conducted by the officers/officials as indicated against each in the Annexure – A to this order. The Chief Accounts Officer will provide details of balance of each godown/sale centre as on 28.02.2023 to the Physical Verification Officers well in advance. The Physical Verification Officers after taking information from the Accounts Branch will check the transactions made by the Storekeepers during the month and furnish the physical verification report/statement in the prescribed proforma (copy enclosed) by or before 10th of April, 2023 positively to the Chief Accounts Officer for examination. The Chief Accounts Officer will ensure receipt of physical verification reports/statements and intimate the position of accounts after verification with ledgers to the undersigned by 15th of April, 2023 positively and shall supervise the financial managements, chest remittances, cash, sale of Ration Cards, dead stocks, stationery articles, etc.

In order to carry on the physical verification of stocks properly and smoothly, the dispatching agencies shall ensure completion of dispatches of foodgrains to each sale outlet as per the requirement upto 20th of March, 2023. The field staff i.e. Tehsil Supply Officers and Storekeepers shall conduct sale of foodgrains upto 31st March, 2023 and there shall be no transaction/ sale after the prescribed date.

It is enjoined upon all the concerned officers/officials entrusted with the job that the verification is conducted strictly as per procedure in vogue and after observing the instructions laid down in the Annexure – B to this order and ensure no delay is caused in furnishing the requisite physical verification reports/statements to this Directorate. Any delay, if noticed, will be viewed seriously and the concerned Physical Verification Officer shall have to face the consequences.
