In continuation to Order No. 708 - DFCS&CAK of 2023 Dated:-16-05-2023 issued under endorsement No. FCS&CA/Plg./ICDS-Alloc/2758-92 Dated:- 16-05-2023 regarding the subject cited above, consequent upon the allotment of Fortified Rice conveyed by the Administrative Department vide above referred communication under the scheme Wheat Based Nutrition Programme (WBNP) and National Food Security Act (NFSA) 2013 for 1st Quarter, 2023-2024 i.e. (April to June 2023), Assistant Director Stores FCS&CA Kashmir is hereby authorized to lift/procure Rice (Fortified) from FCI to the extent of 577.67 MTs under Wheat Based Nutrition Programme (Anganwadi Services) for its further release in favour Assistant Directors of FCS&CA Kashmir Division as per the district wise breakup given in Annexure "A" to this order.

The concerned Assistant Directors shall lift the entire released quantity and ensure its dispatch to the respective sale outlets for its further lifting/distribution by the linked Anganwadi Centres (ICDS).
