Consequent upon the authorization conveyed by the Administrative Department for advance lifting of Foodgrains (Rice and Wheat) from FCI under NFSA/NPHH category in respect of district Anantnag and Kulgam of Kashmir division for two months i.e. July and August 2023 subject to specific conditions. Accordingly;

- Assistant Director Stores FCS&CA Kashmir is hereby authorized for lifting / procurement of 117754.36 Qtls of Rice and 5715.85 Qtls of Wheat from FCI under NFSA/ NPHH category in advance for the month of July & August - 2023 for its further release in favour of Assistant Director Anantnag and Kulgam districts respectively as per the following District wise/ Category wise/ Month wise breakup.

- Assistant Directors FCS&CA Anantnag and Kulgam are authorized to lift the aforesaid quantity of Foodgrains (Rice and Wheat) under NFSA/NPHH in advance for the months of July and August 2023 with the directions that the distribution shall be made through PoS devices only on monthly basis (for respective months) and no manual distribution should be made as directed from time to time.

1. The allocation has been made in advance owing to the exigency as the Mir Bazar Godowns are being utilized by the authorities as a transit camp for Shri Amarnath Ji Yatra.
2. The allocation is purely based on the portal figures frozen for the month of June 2023 by the Administrative Department and no PoS/ other balances have been deducted thus releasing the full requirement of Foodgrains (Rice and Wheat).
3. The Assistant Directors shall be accountable for any misappropriation/ embezzlement or unautomated/ unauthorized sale of foodgrains and hence proper monitoring of the stocks shall be ensured.
4. The Assistant Directors shall ensure that the quantity is distributed in their respective months only as per the entitlement through PoS devices only.
5. The remaining balances shall be calculated on the basis of distribution details depicted on the AePDS portal for the respective months for necessary deductions by the Administrative Department.

The other terms and conditions shall remain same as have been conveyed from time to time.
