Sub:- Re-fixation of seniority of Mr. Ghulam Hassan Itoo, Storekeeper R.No. 4388

Whereas, vide Order No. 255 DFCS&CAK of 2022 dated 19.01.2022 readwith order No. order No.317 DFCS&CAK of 2022 dated 19.03.2022, Mr. Ghulam Hassan Itoo, R.No. 4388 was promoted as Storekeeper in the pay level of Rs. 25500-81100 (L 4) w.e.f. 03.02.2021;

Whereas, Mr. Ghulam Hassan Itoo, SK R.No. 4388 had already represented before this office stated therein that his juniors have found way ahead of him, presently working as I/c TSOs and requested that he may be taken at par with them;

Whereas, the case of Mr. Ghulam Hassan Itoo was placed before the Departmental Promotion Committee held on 09.04.2022;

Whereas, the DPC held on 09.04.2022 examined the instant case and it came to fore that Mr. Ghulam Hassan Itoo, ASK R.No. 4388 was due for promotion as Jr. SK carrying substantive pay scale of Rs.2610-3540 (pre-revised) along with other counterparts in the DPC dated 08.10.2007, however, he was dropped in view of his undecided suspension period in Marwa/ Warwan case;

Whereas, a DPC was conducted on 24.01.2009, wherein he was cleared for promotion as Jr.SK vide order No. 93 DCAPD of 2009 dated 05.02.2009 w.e.f. 24.01.2009 as the period of suspension was treated as on duty vide order No. 131 DCAPDK of 2007 dated 23.11.2007;

Whereas, after 24.01.2009, one more DPC was conducted on 20.11.2010, wherein the said official was promoted as Assistant Storekeeper carrying pay scale of Rs. 3050-4910 (pre-revised) vide order No. 48 DCAPDK of 2011 dated 31.03.2011 w.e.f. 20.11.2010;

Whereas, Mr. Ghulam Hassan Itoo was appearing at seniority No. 1548 in the seniority list of Class-IV officials finalized vide order No. 201 DFSK of 2002 dated 15.02.2002 while as his immediate matriculate junior counterpart namely Mr. Parveez Ahmad Zargar, R.No. 4391 (who is still in service) was appearing at seniority No. 1551 in the said seniority list of Class-IV officials;

Whereas, the records further revealed that Mr. Parveez Ahmad Zargar, R.No. 4391 has been promoted as Assistant Storekeeper w.e.f. 08.10.2007 and as Storekeeper w.e.f. 01.04.2018;

Whereas, the DPC dated 09.04.2022 took the following decision in the case as reproduced hereunder:-



"Cleared notionally from the dates his junior counterparts have been cleared as ASK and SK i.e. as ASK w.e.f. 08.10.2007 and as SK w.e.f. 01.04.2018 respectively"


Whereas, in view of above and as recommended by Departmental Promotion Committee in its meeting held on 09.04.2022, the promotion granted to Mr. Ghulam Hassan Itoo, R.No. 4338 as Assistant Storekeeper in the pay scale of Rs. 3050-4910 (pre-revised) revised 19900-63200/- (L-2) was ordered to take effect from 08.10.2007 and as Storekeeper in the pay level of Rs. 25500-81100 (L4) w.e.f. 01.04.2018 notionally and monetarily with immediate effect vide order No. 397 DFCS&CAK of 2022 dated 24.05.2022;

Whereas, for re-fixation of seniority of Mr. Ghulam Hassan Itoo at appropriate place in the finalized seniority list of Storekeepers, a notification vide No. referred to above was issued by this office for inviting objections, if any, from the interested officials of this department within a period of (07) seven days and it was envisaged in the said notification that no objection shall be entertained after expiry of the stipulated time period;

Whereas, no objection was received by this office within stipulated time period, besides, till date.

Now, therefore, in view of above mentioned facts, the seniority of Mr. Ghulam Hassan Itoo shall be deemed to have been re-fixed at seniority No. 18/A i.e. below Mr. Abdul Ahad Sofi R.No. 4384, Seniority No. 18 and above Mr. Parvaiz Ahmad Zargar R.No. 4391, Seniority No. 19 in the finalized seniority list of Storekeepers issued vide order No. 452 DFCS&CAK of 2020 dated 21.09.2020.
