Whereas, the vigilance clearance has been received in favour of Mr. Popinder Jeet Singh, Mr. Gowhar Yousuf, Mrs. Nazima Nascer Hamdani and Mrs. Zarina Akhtar through online mode vide Form No.194722 dated 20.06.2023, 194718 dated 27.06.2023, 194726 dated 07.07.2023 and 196241 dated 18.06.2023, reporting that there is nothing adverse against the said officials:

Now, therefore, in view of above and as recommended by Departmental Promotion Committee in its meeting held on 13.05.2023, the promotion granted to Mr. Popinder Jeet Singh R.No.5959, Mr. Gowhar Yousuf R.No.5960, Mrs. Nazima Nascer Hamdani R.No.5962 and Mrs Zarina Akhtar, R.No.5957 vide order No. 317 DFCS&CAK of 2022 dated 19.03.2022 as Storekeeper in the pay level of Rs. 25500-81100 (L 4) w.c.f. 03.02.2021 shall take effect from 01.10.2019 notionally (i.e. the date their junior counterparts have been promoted as Storekeeper) and monetarily with immediate effect.
