Consequent upon the allotment of foodgrains (Rice) conveyed by the Administrative Department vide above referred communication under Wheat Based Nutrition Programme (umbrella Integrated Child Development Services) for 2nd quarter, 2021-2022, Assistant Director Stores FCS&CA Kashmir is hereby authorized to lift/procure foodgrains (Rice) to the extent of 2401.4550 MTs under Wheat Based Nutrition Programme for its further release in favour Assistant Directors of FCS&CA Kashmir Division except district Baramulla as per the district wise breakup given in Annexure "A" to this order

The concerned Assistant Directors shall lift the entire released quantity and ensure its dispatch to the respective sale outlets for its further lifting/distribution by the ICDS Department/ Anganwadi Centres.

The above allocation is however, subject to the fulfillment of following terms and conditions that:-

- 1. The Assistant Directors of FCS&CA Kashmir are directed to keep liaison with the concerned Programme Officer ICDS and seek the store wise requirement and frame the lifting strategy thereof.
- 2. The allocated quantity must be lifted from the specified loading point within the stipulated time frame.
- 3. The allocated quantity should be distributed to the identified Anganwadi Centers only and the monthly lifting / off-take statements and consolidated Utilization Certificates on quarterly basis be furnished to this directorate regularly in time without any fail.
- 4. No Diversion/ re-appropriation from one scheme to another or one category to another shall be allowed.

- 6. The Assistant Directors shall be personally responsible for proper distribution of ration amongst the Anganwadi Centers,

  - 9. The ADs shall ensure implementation of the above terms and conditions in letter and spirit. Deviation, if any, shall attract disciplinary action against the erring officer.
