**Subject:- Revised allocation of foodgrains for Inter State/ National Portability for the period April to June 2021 under National Portability (ONORC).**



Consequent upon the allotment of foodgrains conveyed by the Administrative Department vide communication No. CAPD/Plan/ONORC/2020 dated:- 23-08-2021, sanction is hereby accorded to the:-

1. Lifting/ procurement of foodgrains to the extent of **40.55 Qtls viz; 38.98 Qtls of Rice and 1.57 Qtls of Wheat** from FCI by Assistant Director Stores FCS&CA Kashmir under Inter State/ National Portability in addition to NFSA for the period April to June 2021 by 31<sup>st</sup> of August 2021 positively.
2. Release of foodgrains to the extent of **40.55 Qtls viz; 38.98 Qtls of Rice and 1.57 Qtls of Wheat** by Assistant Director Stores FCS&CA Kashmir under Inter State/ National Portability in addition to NFSA for the period April to June 2021 in favour of Assistant Directors of FCS&CA Kashmir division as per the district wise breakup given in **Annexure "A"** to this order.

The Assistant Directors of FCS&CA Kashmir Division shall ensure lifting of allocated foodgrains at an earliest on account of settlement for the period of April to June 2021 under Inter State/ National Portability (ONORC).

Besides, the concerned DPMU units at District Head Quarters be directed to capture and compile the details of transactions on National Portability under IMPDS and furnish the same on monthly basis by or before 5<sup>th</sup> of every month for further projections and allocations.
