- c. The salary of the appointee shall be drawn and disbursed by the concerned Drawing and Disbursing after receipt of satisfactory report in respect of documents
- $\ensuremath{\mathrm{d}}$  . The appointment of the said candidates shall be governed by the Jammu & Kashmir Probationer (Condition of service, Pay and Allowances) and fixation of Tenure Rules 2020 notified vide S.O. 192 of 2020 dated 17.06.2020.
