Consequent upon the selection made by Service Selection Board J&K for the post of Assistant Storekeeper-cum-Clerk (FCS&CA Department, Divisional Cadre Kashmir), directions conveyed by Administrative Department FCS&CA Civil Secretariat J&K vide letter referred to above and subsequent receipt of satisfactory character / antecedents report from Criminal Investigation Department J&K vide letter referred to above, sanction is hereby accorded to the temporary appointment of Mr. Danish Rafiq Dar S/O Mohd Rafiq Dar R/O D.H Pora Kulgam as Assistant Storekeeper-cum-Clerk (Divisional cadre Kashmir) carrying substantive pay level of Rs.19900-63200 (L-2) under Resident of Backward Area Category.

The appointee shall report to the Assistant Director Kulgam Food, Civil Supplies and Consumer Affairs, Kashmir within a period of 21 (twenty one) days from the date of issuance of this order and shall be allowed to join only on production of the following documents / certificates (in original) to be verified subsequently:-


1. Academic Qualification Certificate(s).
2. Date of Birth Certificate.
3. Domicile /Permanent Resident Certificate.
4. Health Fitness Certificate from the concerned Chief Medical Officer concerned.
5. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department (DECC).
6. Reserved category certificate

The appointment of the appointee shall further be subject to the following conditions:-

- a. That he shall give an undertaking in the shape of an affidavit to the effect that if on verification, genuineness of the qualification /reserved category/domicile certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Assistant Storekeeper cum Clerk shall be deemed to have been cancelled *abi-initio* and the legal action as warranted under rules shall be initiated against him.



- b. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) above is received in his favour.
- c. The appointee shall be initially on probation for a period of two years.
- d. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- e. If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego his right to appointment and his appointment shall be deemed to have been cancelled *abi-initio* without any further notice as per Circular No.08-JK(GAD) of 2019 dated 04-12-2019 issued by General Administration Department.
