The appointment of the appointee shall further be subject to the following conditions:-

a. That he shall give an undertaking in the shape of an affidavit to the effect that if on verification, genuineness of the qualification /reserved category/domicile certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Assistant Storekeeper cum Clerk shall be deemed to have been cancelled abi-initio and the legal action as warranted under rules shall be initiated against him.

- b. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) above is received in his favour.
- c. The appointee shall be initially on probation for a period of two years.
- d. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- e. If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego his right to appointment and his appointment shall be deemed to have been cancelled abi-initio without any further notice as per Circular No.08-JK(GAD) of 2019 dated 04-12-2019 issued by General Administration Department.
