- c. The salary of the appointee shall be drawn and disbursed by the concer Drawing and Disbursing Officer after receipt of satisfactory report in respect documents as mentioned at (b).
- d. The appointment of the said candidates shall be governed by the Jammu & Kasi Probationer (Condition of service, Pay and Allowances) and fixation of Te Rules 2020 notified vide S.O. 192 of 2020 dated 17.06.2020.
- The interse-seniority of the appointees shall be as per the order as it exist in selection list as communicated by J&K Service Selection Board.
- f. The appointment and other terms and conditions shall be governed by SRO 4 2009 dated 30.12.2009 issued by Revenue Department.

- g. The appointment of the candidate shall be governed by the "New Pension Scheme" notified vide SRO-400 of 2009 dated 24.12.2009.
