Sanction is hereby accorded to the temporary appointment of Mr. Arjuman Nazran S/O Late Mohammad Ayoub Mir (deceased Watchman) R/o Rakhi Lajhura District Pulwama as watchman (Class-IV/MTS) in district cadre Pulwama carrying substantive pay level of Rs.14800-47100 (SL-I) against the available vacancy in terms of J&K Compassionate Appointment Rules 1994 issued under SRO 43 of 1994.

The appointee shall report to the Assistant Director Pulwama - Food, Civil Supplies and Consumer Affairs, Kashmir within a period of 21 (twenty one) days from the date of issuance of this order and shall be allowed to join only on production of the following documents/ certificates (in original) to be verified subsequently:-

1. Character / antecedents report.
2. Academic Qualification Certificate.
3. Date of Birth Certificate.
4. Domicile Certificate.
5. Health Certificate from the concerned Chief Medical Officer.
6. Dependent Certificate.
7. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
8. All other relevant documents as are required under SRO-43/1994.
9. Affidavit from appointee for maintenance of the dependents.
10. Affidavit from other dependents for NOC

The appointment of the appointee shall further be subject to the following Conditions:-

- a. That he shall give an undertaking in the shape of an Affidavit to the effect that if on verification, genuineness of the qualification/ other certificates from the concerned issuing authority is found fake/ forged, the claim of the appointee for appointment as Class-IV (Watchman) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) is received in his favour.



- c. The appointee shall be initially on probation for a period of two (02) years.
- d. The appointment of the candidate shall be governed by the "New Pension Scheme" As per SRO-400 of 2009 dated 24.12.2009.
- e. If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, he shall forfeit his right to appointment and his appointment shall be deemed to have been cancelled abinitio without any further notice as per Circular No.08-JK(GAD) of 2019 dated 04-12-2019 issued by General Administration Department.
