Consequent upon the allotment of Foodgrains conveyed by the Administrative Department vide above referred communication, the Assistant Director Stores FCS&CA Kashmir is hereby authorized for:-


1. Lifting of **310.00 Qtls** of Rice from FCI under Inter State National Portability (NFSA) within the validity period specified i.e. by or before the **31-08-2023** in addition to regular NFSA.
2. Release of **310.00 Qtls** of Rice in favour of Assistant Directors of FCS&CA Kashmir Division under Inter State National Portability (NFSA) for the months of (April to June 2023) as per the district wise breakup given in Annexure "A" to this order.


The concerned Assistant Directors shall ensure lifting/ dispatch of entire released quantity for utilization strictly as per the directions of the Administrative Department conveyed in the aforesaid communication (annexed herewith for reference).

Further:

- a. The allocation has been conveyed so as to promote transactions under ONORC across Kashmir and to ensure that no beneficiaries are refused to get benefit under ONORC.
- b. The allocation of foodgrains under NFSA for the purpose of Inter state/ National Portability is being done by the Government of India in the ratio 70.99 : 29.01 for Rice and Wheat respectively, in respect of Jammu and Kashmir and thus the distribution under ONORC should be restricted to above ratios (commodity wise) as far as possible and practical.
- c. The Assistant Directors shall ensure mass publicity at grass root level to promote ONORC across J&K for maximizing transactions.
- d. The foodgrains shall be lifted immediately.
- e. The Assistant Directors shall ensure proper reconciliation and monitoring of above said foodgrains for greater transparency.

The above allocation is subject to the fulfillment of other terms and conditions conveyed from time to time.

Besides, mass publicity should be ensured by both the Directorates of FC&CA Jammu/ Kashmir at grass roots level to promote portability for maximization of transactions.

The lifting of foodgrains should be ensured within the validity period.
