
Consequent upon the authorization conveyed by Administrative Department for advance lifting of Foodgrains (Rice and Wheat) from Food Corporation of India under NFSA for the purpose of advance dumping in border areas subject to specific conditions mentioned in the above referred communication dated:- 21-09-2023 (copy annexed).

The Assistant Director Stores/ Mills FCS&CA Kashmir is hereby authorized to lift Foodgrains to the extent of 3152.55 Qtls viz; 3151.92 Qtls of Rice and 0.63 Qtls of Wheat under NFSA from FCI before 10th of October, 2023 for its further release in favour of main borders of Kupwara district as per the category wise breakup given hereunder:
