Whereas, Mr. Mohammad Yaseen Dar, Storekeeper R.No. 4132 was cleared for upgradation in the DPC meeting held on 23.10.2019;


Whereas, the orders for promotion in his favour has not been issued due to pending vigilance clearance as Regular Departmental Action (RDA) was pending before the GAD Vigilance;

Whereas, the Administrative Department vide letter dated 06.01.2021 forwarded copy of O.M No.GAD(Vig)41-RDA/2017 dated 02.12.2020 and its enclosures wherein it was intimated that the ATR (Action Taken Report) in respect of Mr. Mohammad Yaseen Dar has been accepted and the matter stands closed;

Whereas, Mr. Mohammad Yaseen Dar represented before this office stating therein that he was due for promotion as Tehsil Supply Officer in the DPC held on 23.10.2019, however, he was not considered due to non-receipt of vigilance clearance in his favour, which was later on received, but formal promotion order in his favour is yet to be issued;

Whereas, as per the records, the official has put in five years of regular service as Storekeeper as on 16.08.2020 which is pre-requisite for next promotion as per recruitment rules;

Now, therefore in view of above facts, it is hereby ordered that the grade of Tehsil Supply Officer carrying substantive pay level of Rs. 35400-112400 (L6) is released w.e.f. 17.08.2020 in favour of Mr. Mohammad Yaseen Dar R.No. 4132. The seniority of the official shall be determined separately.
