Whereas, after exclusion of employees of Ladakh Division after the enactment of J&K Reorganized Act, 2019 and subsequently exercise of option by them for opting Ladakh UT, a revised tentative seniority list of TSOs/Inspectors has been framed and issued for inviting of objections vide notification referred to above;

Whereas, consequent upon issuance of tentative seniority list of TSOs/Inspector and keeping in view the vacancies of Chief Inspectors which has remained vacant for a long time coupled with suffering of Govt. work it has been felt necessary to get these vacant posts of Chief Inspectors manned by eligible TSOs/Inspectors strictly as per the seniority position;


