Whereas, Mr. Mohammad Younis Ganie, ASK R.No. 4943 made representation before this office stating therein that he has been appointed in this department as Dailywager in the year 1985, promoted as Assistant Storekeeper in the year 2012 whileas the employees of his batch have got functional and well as in-situ promotions from time to time excluding him;

Whereas, the representation of Mr. Mohammad Younis Ganie was examined in light of available records and it came to fore that as per the final seniority list of Class-IV officials issued vide Order No. 201 DFSK of 2002 dated 15.02.2002, Mr. Mohammad Younis Ganie was appearing at seniority No. 2293 above Mr. Gh. Hassan Sheikh, R.No.4944 appearing at seniority No. 2294.

Whereas, in the DPC held on 20.11.2010, Mr. Mohammad Younis Ganie along with his junior counterpart(s) was due for promotion as Jr. Storekeeper carrying substantive pay scale of Rs. 2610-3540 (pre-revised), however, he was not cleared by the said DPC in view of non-availability of integrity/ work and conduct certificate and his post was reserved till next DPC;

Whereas, another DPC was conducted on 28.12.2011, wherein among others, he was cleared for promotion as Jr. Storekeeper prospectively and in the next DPC held on 04.02.2013, the said official was promoted as Assistant Storekeeper w.e.f. 28.12.2011 notionally and monetarily w.e.f. 04.02.2013 vide order No. 209 DCAPDK of 2013 dated 05.08.2013.

Whereas, Mr. Mohammad Younis Ganie and his immediate junior counterpart namely Gh. Hassan Sheikh, R.No. 4944 are presently working as Assistant Storekeepers;

Whereas, Mr. Gh. Hassan Sheikh is appearing at seniority No. 352 while as Mr. Mohammad Younis Ganie is appearing at seniority No.390 in the seniority list of Assistant Storekeepers finalized vide order No. 1008 DFCS&CAK of 2018 dated 14.12.2018;

Whereas, a notification referred to above was accordingly issued by this office for inviting objections, if any, from the interested officials of this department within a period of (15) fifteen days and it was envisaged in the said notification that no objection shall be entertained after expiry of the stipulated time period;

Whereas, no objection was received by this office within stipulated time period, besides, till date;

Now, therefore, in view of above, the seniority of before seniority of Mr. Mohammad Younis Ganie is accordingly re-fixed at 351/A i.e. below Mr. Farooq Ahmad Bhat R.No. 4940 (seniority No.351) and above Mr. Gh. Hassan Sheikh R.No. 4944 (seniority No. 352) in the seniority list of Assistant Storekeepers finalized vide order No. 1008 DFCS&CAK of 2018 dated 14.12.2018
