Whereas, Mr. Mohammad Ramzan Mir, retired ASK-cum-Clerk R.No. 4328 represented before this office stating therein that he was working in this department as ASK-cum-Clerk, retired from services w.e.f.31.03.2017, promoted as ASK-cum-Clerk w.e.f.28.12.2011 and requested for taking him at par with his juniors who have been promoted as ASK-cum-Clerk w.e.f.08.10.2007;

Whereas, his case was placed in the Departmental Promotion Committee meeting held on 03.02.2021;

Whereas, the DPC held on 03.02.2021 considered his case and vide order No. 29 DFCS&CAK of 2021 dated 13.03.2021, his promotion as ASK-cum-Clerk was granted effect w.e.f. 08.10.2007 (i.e. the date his junior counterparts have been promoted as ASK-cum-Clerks) notionally upto 28.02.2017 and monetarily w.e.f. 01.03.2017;

Whereas, Mr. Mohammad Ramzan Mir, Assistant Storekeeper-cum-Clerk R.No. 4328 retired from services on attaining the age of superannuation w.e.f. 31.03.2017;


Whereas, Mr. Mohammad — Ramzan Mir represented before this office for re-fixation of his seniority at appropriate place as per the retrospective effect granted to his promotion as ASK-cum-Clerk w.e.f. 08.10.2007;

Whereas, a notification vide No. DFCS&CAK/Adm/B-X-25 dated 02.06.2021 was issued for inviting objections, if any, from the interested officials of this department within a period of (15) fifteen days from the date of issuance of notification and it was envisaged in the said notification that no objection shall be entertained after expiry of the stipulated time period;

Whereas, no objection was received by this office within the stipulated time period, besides till date;

Now, therefore, in view of above, the seniority of Mr. Mohammad Ramzan Mir, retired Assistant Storekeeper-cum-Clerk R.No. 4328 shall be deemed to have been re-fixed at S.No. 409/A i.e. below Mr. Mohammad Ramzan Dar R.No. 4321 and above Mr. Gh. Hassan Bhat R.No. 4332 in the seniority list of Assistant Storekeeper-cum-Clerks finalized vide order No. 523 DCA&PDK of 2013 dated 28.12.2013
