Whereas, Mr. Nazir Ahmad Waza, ASK- cum-Clerk R.No. 5287 represented before this office stating therein that he was promoted as ASK-cum-Clerk w.e.f 21.09.2013 and requested for taking him at par with his juniors who have been promoted as ASK-cum-Clerks prior to him;

Whereas, his case was placed in the Departmental Promotion Committee meeting held on 03.02.2021;

Whereas, the DPC held on 03.02.2021 considered his case and vide order No 80 DFCS&CAK of 2021 dated 24.04.2021, his promotion as ASK-cum-Clerk was granted effect w.e.f 04.02.2013 notionally (i.e. the date his junior counterparts have been promoted as ASK-cum-Clerks);

Whereas, Mr. Nazir Ahmad Waza, R.No. 5287 was figuring at Seniority No. 2421 i.e. below Mr. Farooq Ahmad Bhat R.No. 5296 (Seniority No. 2420) and above Mst. Fatim un Nisa R.No. 5288 (seniority No. 2422) in the seniority list of Class-IV category of officials finalized vide order No. 201 DFSK of 2002 dated 15.02.2002;

Whereas, the officials namely Mr. Farooq Ahmad Bhat R.No. 5296 and Mst. Fatim un Nisa R.No. 5288 were / are existing at Stry No.'s 449 & 450 respectively in the seniority list of Assistant Storekeeper-cum-Clerks finalized vide order No. 1008 DCA&PDK of 2018 dated 14.12.2018;


