Consequent upon the district-wise allocation of Foodgrains (Fortified Rice) under the Scheme Wheat Based Nutrition Programme (WBNP) and National Food Security Act (NFSA) 2013 conveyed by the Administrative Department vide letter No. FCSCA-Leg1/47/2021-04 (17908) Dated:- 11-03-2024 to meet the requirement of Supplementary Nutrition Programme (ICDS) for 3rd Quarter 2023-2024 whereby the lifting period of Foodgrains (Fortified Rice) for the said period has been revalidated.



Sir/Ma'am,


I am directed to refer to this Ministry's letter of even number dated 29.09.2023 vide which an allocation of 4586.42 MTs (Four Thousand Five Hundred Eighty Six Metric Tons and Four hundred and Twenty Kilograms only) of Fortified Rice was made to Government of Jammu & Kashmir under the Wheat Based Nutrition Programme (WBNP) for the 3rd quarter of 2023-24.

2. In this regard, I am directed to convey the approval of the competent authority to extend the validity period for the lifting of 2640.02 MTs of Fortified Rice against the sub-allocation made by Ministry of Women & Child Development to UT of Jammu & Kashmir under WBNP for the 3rd quarter of 2023-24 and also to extend the validity of lifting for a further period upto 31.03.2024, in pursuance of DFPD's letter No.4-1/2023-BP II (e-382884) dated 01.03.2024.

3. Government of Jammu & Kashmir is requested to ensure lifting of 2640.02 MTs of Fortified Rice allocated under WBNP for the 3rd quarter upto 31.03.2024

4. It may be noted that the above permission has been granted as a special case and one-time measure only. In this regard, Government of Jammu & Kashmir is advised to strictly adhere to the revised guidelines regarding validity period for the timely lifting of foodgrains issued by DFPD vide No.4-7/2018-BP-II dated 25.04.2019.

Consequent upon the allotment of foodgrains (Fortified Rice) conveyed by the Administrative Department vide above referred communication under the scheme Wheat Based Nutrition Programme (WBNP) and National Food Security Act (NFSA) 2013 for **3rd Quarter, 2023-2024 i.e. (October to December 2023)**, the Assistant Director Stores FCS&CA Kashmir is hereby authorized to lift/procure **Rice (Fortified)** from FCI to the extent of **2532.6175 MTs** under Wheat Based Nutrition Programme (Anganwadi Services) for its further release in favour of Assistant Directors of FCS&CA Kashmir Division as per the district wise breakup given in **Annexure "A"** to this order.


The concerned Assistant Directors shall lift the entire released quantity and ensure its dispatch to the respective sale outlets for its further lifting/distribution by the linked Anganwadi Centres (ICDS).

The above allocation is however, subject to the fulfillment of following terms and conditions that:-

1. The Assistant Directors of FCS&CA Kashmir are directed to keep liaison with the concerned district Programme Officers ICDS and seek the store wise requirement and frame the lifting strategy thereof.
2. The allocated quantity must be lifted from the specified loading point within the stipulated time frame.
3. The allocated quantity should be distributed to the identified Anganwadi Centers only and the monthly lifting / off-take statements and consolidated Utilization Certificates on quarterly basis be furnished to this directorate regularly in time without any fail.



4. No Diversion/ re-appropriation from one scheme to another shall be allowed.
5. The Assistant Directors shall be personally responsible for proper distribution of ration amongst the Anganwadi Centers.
6. The Assistant Directors shall keep strict vigil against pilferage/ misappropriation reported at any sale outlets under their respective jurisdictions.
7. A separate physical/financial account should be maintained.
8. The ADs shall ensure implementation of the above terms and conditions in letter and spirit. Deviation, if any, shall attract disciplinary action against the erring officer.
